Purpose: The purpose of this Addendum is to make changes, additions, deletions, revisions and clarifications to the bid documents issued Friday, 14th January, 2022 for the project referenced above. Bidders shall review the Addenda and requirements in detail and incorporate any effects the Addendum may have on their bid price.

Acknowledgement: Bidders must acknowledge receipt of any and all Addenda. All requirements of the bid documents remain unchanged except as cited herein.

AMMENDMENTS:

The following revisions and amendments have been made to the named sections and items in the Bidding Document (all amendments included blue for ease of reference):

1. Schedule A – Instructions for Bidders Section **2.4** Qualifications for Bidders has been amended as follows:

2.4 Qualifications for Bidding

A bid submitted without the below-listed documents is considered incomplete and will fail to qualify as a bid during the evaluation process thereby rendering the bid ineligible for consideration for further evaluation or award of contract:

- a) a valid Tax Clearance Certificate;
- b) a valid Business Licence in the relevant field;
- c) a letter of good standing with Social Security; and
- d) proof of valid liability insurance of at least US\$500,000.00.
- e) clean police/criminal records for each person proposed for employment under this contract.
- f) 5 year work history for each person to be employed under this contract.
- 2. Schedule B Conditions of Bidding Section 11.2 Technical Criteria Attributes, Technical Resources (item 1) has been amended as follows:

3. Schedule C – General Conditions of Contract, Section 7 Contractor's Obligations. An additional item has been added:

(6) The contractor shall ensure that the security officers and proposed substitutes identified under this contract undertakes and passes the training requirements in accordance with the provisions of this contract.

4. Schedule C – General Conditions of Contract, Section 9 Personnel of the Contractor. An additional item has been added:

(6) The CONTRACTOR shall ensure that the personnel identified for the carrying out of this CONTRACT will undertake and pass all training requirements in accordance with the provisions of this contract. If at any time during the CONTRACT PERIOD, in the opinion of the AURTHORIZED OFFICER, there are fewer adequately trained persons that is required, the CONTRACTOR shall take all proper steps to ensure that additional otherwise qualified persons are made available for the training.

5. Schedule C – General Conditions of Contract, Section 18 Termination. An additional item has been added:

(5) If the security officers, including the substitutes, identified to perform under this contract fails to complete and pass the stipulated training programmes after a two (2) number of attempts and in accordance with this CONTRACT, AASPA shall be entitled to TERMINATE the CONTRACT.

- 6. Schedule D Specification/Scope of Works, Section 2. Basic Services (2.c) has been amended as follows:
 - c. Provide 5 officers to the general security of the Clayton J. Lloyd International Airport, daily, from 05:45am to 7:00pm to:

- e. A minimum of 5 additional officers, to serve as substitutes for the proposed security officers when necessary, should be included in staffing list as allowed for in the bid return form. These additional security officers shall be required to complete and pass the required training programmes along with the other proposed security officers.
