A sign-in sheet will be circulated and attendance is encouraged.

Bids should be received no later than **Wednesday**, **16**th **August 2023 at 3:00 p.m.** Late bids will be rejected. **TECHNICAL** Bids will be opened publicly at the address above on **Wednesday**, **16**th **August 2023 at 3:05 p.m.** Bids meeting the minimum technical criteria to qualify will be evaluated for price. Eligible Bidders will be advised of the **FINANCIAL** Bid Opening date and time in accordance with the Public Procurement and Contract Administration legislation. The GOA is not bound to accept the lowest of any bids. This bid process may be cancelled or rejected without any liability to GOA.
