The Ministry of Infrastructure, Communications, Utilities and Housing and Tourism (MICUHT) intends to apply a budgetary allocation to payments under a contract for the Airport Redevelopment Program Package 2 – Cargo Building. The MICUHT now invites sealed bids from eligible bidders for the Airport Redevelopment Program Package 2 – Cargo Building as defined within the bidding documents. The contract period is for Six Months (6) months with a Twelve (12) month defects liability period.

Bidding will be conducted through a Competitive Bid procedure in keeping with the Public Procurement and Contract Administration Acts and Regulations.

All interested bidders shall be limited to two (2) persons and shall meet immediately on Long Ground Road at the site of the proposed Cargo Building. A sign-in sheet will be circulated and attendance is encouraged.

*Bids* should be received no later than **Friday, 8<sup>th</sup> September 2023 at 3:00 p.m.** Late bids will be rejected. *Bids* will be opened publicly at the address above on **Friday, 8<sup>th</sup> September 2023 at 3:05 p.m.** Bids meeting the minimum technical criteria to qualify will be evaluated for price. The GOA is not bound to accept the lowest of any bids. This bid process may be cancelled or rejected without any liability to GOA.
