The Ministry of Infrastructure, Communications, Utilities and Housing and Tourism (MICUHT) intends to apply a budgetary allocation over the coming years to execute on this project, subject to availability of funding.

The MICUHT now invites sealed responses to the Request for Expression of Interest (REOI) from eligible bidders for the Airport Redevelopment Program Package 3 – Air Terminal Building as defined within the Request for Expressions of Interest. In the assessment of submissions, considerations will be given to Company Profile, Personnel, Project Profiles, Methodology, Schedule and Risk Mitigation, Overall Quality of the Submission, Health and Safety, Bonding and Insurance – *brochures may be included*.
