This is in order to allocate prior claims between Life & PA and also to ascertain if any hazardous occupations are included (police force/coast guard/fire services etc.) particularly in respect of Anguilla Air and Sea Ports Authority and Public Utilities Commission.

- **Q1:** Please advise any changes in the request for terms when compared to the previous tender.
- **Q2:** Claims history minimum 5 years, splitting out the life and AD & D claims.
- Q3: Numbers of insureds last 5 years.
- **Q4:** We note that reference is made to retirees. Previously we understood cover was for employees only. Are all retirees to be covered?

- Q7: Covid vaccination take up of group (if this data is available)?
- **Q8:** In the event of Accidental Death are both the AD and Life benefits payable i.e. double benefit of EC\$100k?" You answered that just a single EC\$50k would be payable
